Scholarships

Each year FCAI grants scholarships to those pursuing higher education. Since 1992, FCAI has awarded 513 scholarships totaling \$532,250. Each FCAI Contractor Company can nominate one person to receive a scholarship and the nominee is not required to be related to or employed by a FCAI contractor.

Rebate Program

FCAI hosts an annual supplier trade show where FCAI contractor companies receive a determined dollar amount to spend with any of the suppliers present. In the last several years, FCAI has given between \$1,000-\$5,000 to each contractor company. This program could save your company thousands of dollars.

Tri-Council Development Fund (TCDF) - Asset Protection Program - Corrosion Illinois Network

The TCDF is a group made up of the Associations FCAI, FCAC and AGC (Central IL) along with DC 30, DC 14 and 58. The Asset Protection Program offers to government entities, municipalities and others, an evaluation and a 10-year water system asset protection plan at no cost. The plan identifies developing problems and provides a comprehensive report on their assets and plan to maintain those assets. This program will increase the use of FCAI Union industrial coatings workers in our areas.
