WAGE RATE SHEET: EFFECTIVE JUNE 1, 2025 - MAY 31, 2026

Wage Rates are determined by three established Wage Zones, which correspond to the various local unions (Contract Types) that comprise PDC 30's jurisdiction. When a Bargaining Unit Employee works in any Zone, the Employee shall receive the higher of: (1) the hourly wage rate for the Zone in which the Employee's Local Union is chartered (the "Employee's Home Zone"), or (2) the hourly wage rate for the Zone where the work is being performed. The Combined Fringe Benefit Rate combines the fund contributions to be paid on each covered employee. PDC 30 Pension contributions are not required on behalf of Apprentices, therefore Combined Fringe Benefit Rates vary for Journey Workers & Apprentices.
